

HEARING OFFICER ORDER

On September 8, 2011, all parties participated in a telephonic status conference with the hearing officer. The complainant stated that the parties have recently agreed on a penalty and the complainant will draft a stipulation and proposal for settlement (stipulation). By agreement, respondents' answers or other pleadings are now due on or before November 23, 2011.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on November 10, 2011, at 9:45 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a stipulation is filed prior to the next status conference, the conference will be cancelled without further notice.


