

HEARING OFFICER ORDER

On September 15, 2011, a telephonic status conference was held with the hearing officer. The petitioner stated that more issues have been resolved since that last status conference. The petitioner further stated that it anticipates a resolution in this matter without the necessity of a hearing, but that a few issues remain to be settled. The respondent stated that it has had three meetings with the intervenor since the last status conference reviewing settlement proposals. The petitioners also stated that they will file an additional 120 day waiver of the statutory decision deadline.

The parties are directed to participate in a telephonic status conference with the hearing officer on December 15, 2011, at 11:30 a.m. The status must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a motion to voluntarily dismiss is filed prior to the next status conference, the conference will be cancelled without further order.


