## <u>FIFTH MOTION FOR EXTENSION OF TIME IN WHICH TO FILE</u> AGENCY'S RECOMMENDATION OF THE PETITION FOR ADJUSTED STANDARD

NOW COMES Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY ("Illinois EPA"), by its attorney, Charles E. Matoesian, and pursuant to Section 101.522 of the Illinois Pollution Control Board rules moves that the Hearing Officer extend the time for the Illinois EPA to file the recommendation on the petition for adjusted standard in the above captioned matter to October 11, 2011. In support of its Motion, the Illinois EPA states as follows:

- 1. On January 27, 2011, Illinois EPA received a Petition for Adjusted Standard filed on behalf of Greif Packaging, LLC ("Greif").
- 2. Under 35 Ill. Adm. Code 104.416, Illinois EPA must file with the Board the recommendation of the Agency on the petition for adjusted standard within 45 days of notice of the petition.
- 3. Illinois EPA previously requested an extension to April 11, 2011, as the Illinois EPA is in discussions with Greif about the terms of the Petition.
- 4. Illinois EPA previously requested an extension to May 11, 2011, as the Illinois EPA is in discussions with Greif about the terms of the Petition.
- 5. Illinois EPA previously requested an extension to June 13, 2011, as the Illinois EPA is in discussions with Greif about the terms of the Petition.

6. On May 31, 2011, Greif filed an Amended Petition for an Adjusted Standard.

This extended the Illinois EPAs filing date to July 15, 2011.

7. On August 12, 2011, the Petitioner filed a Second Amended Petition.

8. In mid-September, Greif presented the Illinois EPA with new information

requiring additional analysis.

9. As the Illinois EPA is still discussing the petition with the Petitioner, the Illinois

EPA requests another short extension to October 11, 2011, for filing its response to the petition.

10. During a telephone conversation on September 22, 2011, the attorney representing

Petitioner agreed to this extension.

**WHEREFORE**, for the reasons set forth above, the Illinois EPA respectfully

requests that the Board grant an extension until October 11, 2011, for the Illinois EPA to file its

recommendation of the petition for adjusted standard.
