35 Ill. Admin. Code § 101.308(c)(2), and hereby agrees to a limited waiver of the

statutory 120-day decision deadline for final action by the Illinois Pollution Control

Board ("Board"), in the above-referenced proceeding, until May 17, 2012. In support of

- 1. On December 9, 2009, Petitioner reissued a Clean Air Act Permit Program
