HEARING OFFICER ORDER


On December 8, 2011, all parties participated in a telephonic status conference with the hearing officer. The parties stated that additional discovery is needed to assist in the prospect of filing a motion or notice to withdraw the only contested issue in this appeal (incompleteness determination). Due to the need of additional discovery, petitioner's response to respondent's motion to withdraw contested issue is now due to be filed on or before February 10, 2012.

The petitioner stated that it will file a 60 day waiver of the statutory decision deadline.

By agreement, the record in the above-captioned appeal is now due to be filed on or before February 10, 2012.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on January 26, 2012, at 2:30 p.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


