PETITION FOR REVIEW

Now comes the Respondent, Loves Park Auto Parts, Inc., by and through its attorney, Darlene D. Soderberg, and for its Petition for Review, states as follows:

- 1. On September 20, 2011, Inspector Donna Shehane was at Respondent's site for an inspection. Inspector Shehane left the premises without informing Respondent of any violation.
- 2. Respondents never received a verbal or written report for the September 20, 2011 inspection, thus Respondent was unaware of any violations.
- 3. On October 4, 2011 Inspector Shehane performed another inspection at Respondent's site and left without verbal acknowledgment or discussion of any violations.
- 4. Respondent never received a verbal or written report for the October 4, 2011 inspection, thus Respondent was unaware of any violations.
- 5. Nevertheless, on or about November 17, 2011, the Illinois Environmental Protection Agency filed an Administrative Citation against the Respondent, Loves Park Auto Parts, Inc.
- 6. The citation alleged that the Respondent was in violation of the Illinois Environmental Protection Act 415 ILCS 5/31.1, in "that respondent caused or allowed open dumping of waste in a manner resulting in used tires, at this site, not altered, covered or otherwise prevented from accumulating water."
- 7. The Respondents contacted Inspector Donna Shehane and Assistant Counsel Michelle Ryan to discuss the citation and ask for dismissal based on the fact no verbal or written report for either the September 20, 2011 or the October 4, 2011 inspections.

- 8. Furthermore, without verbal or written communication between the Respondent and the Inspector, the interpretation of the Environmental Protection Agency codes and alleged violations remained unclear between the parties.
- 9. After the violation was clarified with Inspector Shehane, Respondents resolved the issue by emptying all tires of water and placing tarps over all tires to prevent the accumulation of water.

Wherefore, the Respondent, Loves Park Auto Parts, Inc. requests that the Illinois Pollution Control Board grant its Petition for Review and further find that the Respondent is no longer in violation of the Illinois Environmental Protection Act and, therefore, not subject to any civil penalty.
