HEARING OFFICER ORDER



On January 12, 2012, all parties participated in a telephonic status conference. The parties stated that they continue in their efforts to resolve these consolidated appeals. In particular, access, for purposes of testing, remain unresolved for two of the six of the neighboring sites. The petitioner, however, stated that they are close to an access agreement with the remaining two sites.

The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including June 7, 2012.

The parties or their legal representatives are reminded and directed to appear at a telephonic status conference with the hearing officer on February 9, 2012, at 9:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




