HEARING OFFICER ORDER


On January 26, 2012, all parties participated in a telephonic status conference with the hearing officer. The respondent stated that it intends to file a joint motion to dismiss the above-captioned appeal within the next 14 days. Included in the motion will be language addressing respondent's request to withdraw the only issue in contention.

The petitioner stated that it will file a 120 day waiver of the statutory decision deadline.

To that end, the record in the above-captioned appeal is now due to be filed on or before March 16, 2012.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on March 8, 2012, at 1:00 p.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




