

**HEARING OFFICER ORDER**

On January 26, 2012, all parties participated in a telephonic status conference with the hearing officer. The parties stated that they have exchanged settlement offers and continue settlement discussions. The complainant is reviewing ability to pay documents provided by the respondent. A proposed discovery schedule was submitted and is accepted to the extent as follows. The complainant must respond to respondent's affirmative defenses on or before February 15, 2012. All written discovery, including interrogatories and document production requests must served on or before March 31, 2012. Responses to written discovery must be served on or before May 15, 2012. Depositions to be noticed between May 31, 2012, and August 31, 2012. Service of requests for admissions must be served on or before September 15, 2012. Responses to the requests to admit must be served on or before October 15, 2012. The cut-off date for all discovery is October 15, 2012.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on April 19, 2012, at 10:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


