HEARING OFFICER ORDER		

On January 31, 2012, the respondent filed a motion for leave to file a reply to complainant's response to motion for summary judgment. In the respondent's affidavit of service, it is noted that complainant was served via electronic mail on January 31, 2012.

Under the Board's procedural rules at 35 Ill. Adm. Code 101.506 (d), if no response is filed by a party "[w]ithin 14 days after service of a motion", then "the party will be deemed to have waived objection to the granting of the motion: Complainant has not filed a response.

The respondent's motion is granted and its reply is due to be filed on or before March 12, 2012.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on March 8, 2012, at 11:00 a.m. The telephonic conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
