### <u>AFFIDAVIT</u>

- I, Michelle M. Ryan, being first duly sworn upon oath, depose and state as follows:
- 1. I am employed by the Illinois Environmental Protection Agency ("Illinois EPA"), as Assistant Counsel for the Bureau of Land.
- 2. As part of my duties, I am responsible for the preparation of Administrative Citations issued by the Illinois EPA and the negotiation and litigation of appeals filed pursuant to such Administrative Citations. As part of my job experience, I have also submitted travel vouchers for reimbursement.
- 3. I have reviewed the Illinois EPA Division of Legal Counsel File 305-10-AC, which relates to AC 11-13, *Illinois EPA v. Ray Newingham*, for the purpose of determining the costs expended by Illinois EPA.
- 4. I was the Illinois EPA attorney assigned to handle the hearing for AC 11-13, which was held in Carollton. I was required to travel from Springfield to Carollton and back for the hearing. The Illinois Department of Transportation map of the State of Illinois indicates that the distance between Springfield and Carollton is 70 miles. Based on my own job experience, I am aware that the approved mileage reimbursement rate in November 2011 was \$.50 per mile.
- 5. On November 2, 2011, I traveled to the hearing in this matter as well as another hearing in Carrollton for a hearing on AC 10-21, *Illinois EPA v. David Charles Bettis*. As a

result, I made one round trip for a total of two hearings. Therefore, Illinois EPA is claiming half of these actual mileage costs for this matter, totaling \$35.00.
