
HEARING OFFICER ORDER

On March 7, 2012, all parties participated in a telephonic status conference. The parties stated that they continue in their efforts to resolve these consolidated appeals. The petitioner stated that it has acquired access for all but one of the neighboring sites in which to proceed with testing. The petitioner stated that it remains close to an access agreement with the remaining site.

The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including August 23, 2012. By agreement, the record in the above-captioned consolidated appeals is now due to be filed on or before May 31, 2012.

The parties or their legal representatives are reminded and directed to appear at a telephonic status conference with the hearing officer on April 19, 2012, at 9:15 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




