MOTION TO LIFT THE STAY OF PROCEEDINGS, SUPPLEMENT THE RECORD, AND REQUEST A DECISION

Cabot Corporation ("Cabot"), through its attorneys, Seyfarth Shaw LLP, and pursuant to 35 Ill. Admin. Code §§ 101.500, moves the Board to lift the current stay of proceedings, supplement the record in this matter, and issue a decision. In support of this motion, Cabot states as follows:

- 1. On September 16, 2011, Cabot filed a Petition with the Board seeking modification of its adjusted standard from the Illinois state underground injection control ("UIC") regulations for Wells Nos. 2 and 3 at its Tuscola, Illinois facility.
- 2. At the same time, Cabot filed a Motion to Stay Proceedings. The Motion to Stay requested that the Board stay further action on Cabot's Petition until the U.S. EPA took final action on a similar petition under the federal program. The Motion to Stay explained that staying the proceeding until the U.S. EPA took action, "will assist the Board in making the appropriate determination and ensure that the Board does not apply more stringent law to Cabot than is warranted under the circumstances." September 16, 2011 Motion to Stay, at Par. 7.
- 3. On November 17, 2011 the Board entered an order staying this proceeding until May 10, 2012.
 - 4. On March 9, 2012, the U.S. EPA issued its approval of Cabot's petition under the Printed on Recycled Paper

federal hazardous waste disposal injection regulations (hereafter "U.S. EPA Notice") (see attached).

- 5. Now that the U.S. EPA has approved Cabot's petition, Cabot requests that the Board lift the stay and proceed to a decision in this matter. Cabot asks that the Board's Order lifting the stay provide the IEPA forty-five (45) days to file its Recommendation and Cabot fourteen (14) days thereafter to file its Response (if necessary).
- Cabot also requests leave to supplement the record in this matter with the attached 6. copy of the U.S. EPA Notice.
 - 7. Cabot has not requested a hearing in this matter.

WHEREFORE, Cabot Corporation requests that the Board lift the stay, supplement the record with the U.S. EPA's Notice, and proceed to a decision in this matter.

We have received your letter requesting a change of the maximum limits for temperature and pH of Cabot's injected waste stream. We have determined that these changes will not invalidate the demonstration of no migration and are therefore considered to be a nonsubstantive revision of the exemption. To satisfy Condition 5 of the exemption which states: "The concentrations of constituents of the injected waste will not exceed the amounts listed in Table 1-1 in the petition document," we will replace Table 1-1 containing the original limits with Table 1-1a containing the new pH and temperature limits in the administrative record for this exemption.
