## NOTICE OF LIMITED WAIVER OF 120-DAY DECISION DEADLINE

NOW COMES Petitioner, THE PREMCOR REFINING GROUP INC.

("Petitioner"), by and through its attorneys, HODGE DWYER & DRIVER, pursuant to

35 Ill. Admin. Code § 101.308(c)(2), and hereby agrees to a limited waiver of the

statutory 120-day decision deadline for final action by the Illinois Pollution Control

Board ("Board"), in the above-referenced proceeding, until October 18, 2012. In support

of this Notice, the Petitioner states as follows:

- 1. On December 9, 2009, Petitioner reissued a Clean Air Act Permit Program
  Permit ("CAAPP") that was the subject of appeal in *The Premcor Refining Group Inc. v.*Illinois Environmental Protection Agency, PCB 07-30.
- 2. On January 27, 2010, Petitioner filed a Petition requesting a hearing on the Illinois Environmental Protection Agency's ("Illinois EPA") action to issue a CAAPP permit in a fashion that does not reflect the current applicable requirements or the current operation of the facility, and also filed a Motion to Stay Effectiveness of the CAAPP Permit.
  - 3. On February 4, 2010, the Board accepted Petitioner's petition for hearing.
