They are located on the south side of the intersection of Book Road and 111th Street, immediately next to the Riverview Farmstead in the Will County Forest Preserve.

My husband spoke with you briefly in order to obtain your email address on April 19th, the day after we returned from our spring vacation. While we were gone, we had received a letter in the mail from Dean Olson, from the Land Use Department in Will County, which was the first time we learned of the proposed CCDD operation. Since this proposed site will be located quite close to our home, we were quite concerned about the potential impact on our well water, as well as potential negative impact on our home value and increased noise from truck traffic.

We would like our comments to be noted for the record and considered in the upcoming rulemaking decision. Hopefully, the opportunity for recording our comments has not closed since we have only had knowledge of the situation for less than a week.

Currently, we have a well on our property which supplies all of our water for drinking and other purposes. Dean Olson has proposed that a baseline water sample be taken from our private well, to which we are in full agreement. Also, a sample should be taken from the other family as mentioned above. We would also request that periodic water samples be taken and compared to the baseline results, so that we can know whether the CCDD operation has had a negative impact on our drinking water.

After reviewing all of the pertinent related materials associated with this permit, which are available online, we would like our comments to be entered into the record as follows:
