2. Respondents' Motion to Reconsider the Board's Order dated April 5, 2012 is timely filed pursuant to 35 Ill.Adm. •\$25,000 to Robert Pruim severally for the eight counts adjudicated against CLC and the Pruims (10 violations);

•\$25,000 to Edward Pruim severally for the eight counts adjudicated against CLC and the Pruims (10 violations);

and, for such other or different relief as the Board may order.
