

HEARING OFFICER ORDER

On May 14, 2012, all parties participated in a telephonic status conference with the hearing officer. The respondent and the intervenors stated that they intend to file respective motions for summary judgment on or before July 9, 2012. The petitioner stated that upon receipt of the remaining discovery, it may file a cross-motion for summary judgment. Briefing schedules will be revisited at the next status conference. The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including January 11, 2013.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on June 25, 2012, at 11:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


