
HEARING OFFICER ORDER

On May 24, 2012, a telephonic status conference was held. Respondent Frederick Slayton did not appear. The parties reminded the hearing officer that there is a companion case proceeding in the state circuit court. The respondent Cioni Excavating Inc. again stated that it may file appropriate pleadings contesting the concurrent actions.

The complainant stated that respondent Fredrick K. Slayton has yet to forward a remediation proposal to the complainant which is a month overdue.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on June 28, 2012, at 11:15 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




