ILLINOIS EPA'S FIRST NOTICE COMMENTS

NOW COMES the Illinois Environmental Protection Agency ("Illinois EPA"), by one of its attorneys, Kimberly A. Geving, and pursuant to 35 Ill. Adm. Code 102.108, respectfully submits these FIRST NOTICE COMMENTS in the above-captioned matter to the Illinois Pollution Control Board ("Board").

In the Board's First Notice Opinion and Order¹, dated April 19, 2012, the Board solicited comments from the Illinois EPA on a number of different issues. The sole intent of these FIRST NOTICE COMMENTS is to address those issues raised by the Board.

- 1. The Board's first request of the Illinois EPA was to comment on whether the more recent publication of ASTM E 2600-08 (latest edition being ASTM E 2600-10) should be incorporated by reference in Section 742.210 (Order at 15). The Illinois EPA is amenable to incorporating the latest edition of that ASTM methodology.
- 2. The Board's second request was that the Illinois EPA address whether TACO provisions on similar-acting chemicals would apply with respect to remediation objectives for the indoor inhalation pathway and, if so, how they would apply. (Order at 21)

The Illinois EPA is not applying the TACO provisions on similar-acting chemicals to the soil gas or groundwater remediation objectives because no one is exposed to the chemicals in

soil gas or groundwater while these media are still in the ground. Human contact with the chemicals in soil gas or groundwater occurs only after the chemicals potentially migrate indoors. This follows the reasoning behind not applying the provisions on similar-acting chemicals to the soil component of the groundwater ingestion route of exposure; human contact with a chemical for this pathway occurs only after the chemical migrates to the groundwater and someone drinks the contaminated groundwater.

3. The Board's third request was that the Illinois EPA explain whether the use of the slab-on-grade scenario is protective of basement occupants of a building. (Order at 23)

As the Board has noted (Order at 22), the Illinois EPA selected the slab-on-grade scenario as the default scenario for Tier 1 indoor inhalation remediation objectives because it is the more conservative option. USEPA's *User's Guide for Evaluating Subsurface Vapor Intrusion into Buildings* (2004) states that the J & E model assumes that subsurface volatiles migrating into the building are completely mixed within the building volume, and that the default value chosen for building mixing height for a basement scenario is representative of a two-fold reduction or attenuation in vapor concentrations between floors.

The Illinois EPA conducted a sensitivity analysis to compare Tier 1 residential remediation objectives for benzene and tetrachloroethylene (PCE) for a basement scenario and for a slab-on-grade scenario. The results (presented in Exhibit A to these comments) support our conclusion that slab-on-grade is the appropriate scenario to use for Tier 1 remediation objective tables for the indoor inhalation exposure pathway.

More recently, the Illinois EPA reviewed USEPA's Vapor Intrusion Screening Level Calculator User's Guide (March 2012). For that screening tool, no distinction is made between the basement and slab-on-grade scenario. The document states on page 2, "The receptors are

assumed to be occupants in buildings with poured concrete foundations (for example, basement or slab on grade foundations or crawlspaces with a liner or other vapor barrier)." It would appear that the distinction between slab-on-grade and basement construction no longer matters; instead, the concern is for buildings with significant openings to the subsurface. Under the Illinois EPA's proposal, all buildings are assumed to have concrete foundations as required by Section 742.717(d)(2).

For these reasons, the Illinois EPA is confident that the proposed Tier 1 indoor inhalation remediation objectives for soil gas and groundwater are sufficiently protective of basement occupants.

- 4. The Board's fourth request was that the Illinois EPA commit to evaluating USEPA's new vapor intrusion guidance when it becomes available and timely file any proposed TACO amendments based on the evaluation.² (Order at 27) The Illinois EPA commits to do such evaluation and timely file any amendments to TACO, if appropriate and necessary.
- 5. The fifth item raised by the Board, although not a specific request for comment from the Illinois EPA, was the modification to Section 742.105 to "better reflect IEPA's intent."

 (Order at 29) The Illinois EPA concurs with the modification and appreciates the Board's effort to further clarify our intent regarding the applicability of TACO.
- 6. The next request by the Board was that the Illinois EPA and members of the regulated community comment on "whether the TACO amendments taking effect would preclude the subsequent issuance of a limited NFR Letter in SRP, such as one explicitly providing that the indoor inhalation exposure route was not addressed." (Order at 40-41)

It has always been the Illinois EPA's contention that the law in effect at the time an application, request, report, etc. is received by the Illinois EPA is the law that applies. Therefore,

anything submitted to the Illinois EPA (e.g., applications or completion reports) prior to the delayed 60-day effective date would fall under the law that existed prior to these 2012 amendments. Likewise, if an application, plan, or report is submitted to the Illinois EPA subsequent to the delayed 60-day effective date, then the submitter should be prepared to comply with all new amendments, including addressing the new indoor inhalation pathway.

As expressed by the Illinois EPA in testimony at hearing, the regulated community has been on notice of the proposed changes for a considerable amount of time. The addition by the Board of a delayed effective date further helps to accommodate parties with the transition. Therefore, the Illinois EPA believes that if parties wish to follow the old law, they should have all remediation activities completed and all reports submitted to the Illinois EPA prior to the final effective date established by the Board. The regulated community may not pick and choose which pathways they wish to address and, likewise, cannot request an NFR Letter limited to a specific pathway.

- 7. The Board modified the Illinois EPA's definition of "Building" to further define the Illinois EPA's intended meaning of "intended for or supports human occupancy." (Order at 42) The Illinois EPA concurs with the Board's modification to the definition and finds it consistent with Illinois EPA's intent.
- 8. The Board requested that the Illinois EPA provide information to support its proposal to decrease the minimum membrane thickness of a sub-membrane depressurization system from 0.15mm (6 mil) in our original R09-9 proposal to the current proposal in R11-9 to 0.10mm (4 mil). The Board also requested that the Illinois EPA respond to CETCO/Geokinetic's advocacy of a minimum 60 mil membrane thickness. (Order at 44)

For sub-membrane depressurization systems, which are actively vented systems intended for use in existing buildings with crawlspaces, the Illinois EPA originally proposed a 6 mil cross-laminated membrane, but reduced it to a 4 mil cross-laminated membrane in response to a recommendation by David Folkes at EnviroGroup Limited.

In the interval between R09-9 and R11-9, the Illinois EPA asked Mr. Folkes to review proposed Part 742, Subpart L: Building Control Technologies. Mr. Folkes provided his comments as a professional courtesy. We sought Mr. Folkes's opinion because of his experience mitigating hundreds of homes affected by volatile organic chemical contamination from the Redfield Rifle Scope facility in Denver, Colorado (Design, Effectiveness, and Reliability of Sub-Slab Depressurization Systems for Mitigation of Chlorinated Solvent Vapor Intrusion by David J. Folkes, P.E., presented at the USEPA Seminar on Indoor Air Vapor Intrusion, San Francisco, December 4, 2002; Dallas, January 15, 2003; and Atlanta, February 26, 2003, USEPA Office of Research & Development).

USEPA has also recommended using a 4 mil cross-laminated membrane for submembrane depressurization systems (Radon Reduction Techniques for Existing Detached Houses, 1993, Technical Guidance 3rd Edition for Active Soil Depressurization Systems, page 232). Though this federal guidance is intended for radon mitigation and is nearly 20 years old, its membrane thickness specification for sub-membrane depressurization systems has been affirmed by the Interstate Technology and Regulatory Council's Vapor Intrusion Pathway: A Practical Guide (2007, page 53).

The New York State Department of Health recommends using a 3 mil cross-laminated membrane for sub-membrane depressurization systems (Guidance for Evaluating Soil Vapor

Intrusion in the State of New York, October 2006, New York State Department of Health, Center for Environmental Health, Bureau of Environmental Exposure Investigation, page 62).

On May 1, 2012, the Illinois EPA contacted Kevin Lea at Geokinetics by phone and email to request clarification of the comments he and his colleagues at CETCO/Geokinetics provided in pre-filed testimony dated February 23, 2009. On May 14, 2012, Kevin Lea replied to us by email, stating that Geokinetics stands by its original testimony in recommending a 60 mil membrane for the sub-membrane depressurization system. The Illinois EPA respectfully disagrees with the opinion of CETCO/Geokinetics. Our proposed membrane specifications for sub-membrane depressurization systems are supported by USEPA, the Interstate Technical and Regulatory Council, and the New York State Department of Health; none of these entities has a commercial interest in recommending a minimum membrane thickness.

9. In its discussion of building control technology ("BCT") maintenance requirements, the Board brings up the fact that two terms are used in the Illinois EPA's proposal that have not been defined in Section 742.200. Those terms are "intrusive activities" and "rendered inoperable." The Board has requested comments from participants in the rulemaking as to whether those terms should be defined. (Order at 45) The Illinois EPA believes that it would be prudent to define those terms and offers the following definitions for the Board's consideration.

"Intrusive activities" means activities that would affect potential flow of contaminants into a building (e.g., breaching the integrity of a foundation due to repairs or installation of utilities).

"Rendered inoperable" means having become unable to operate effectively, including, but not limited to, being shut down as part of routine maintenance or due to a malfunction, power failure, or vandalism.

10. The Board has requested that the Illinois EPA address the following with regard to BCTs: (a) whether there would be any disadvantages to requiring that the Illinois EPA be notified if a BCT becomes inoperable at a school site; (b) comment on inclusion of the following sentence in Section 742.1200(e)(3): "For a school, the site owner/operator shall notify the Agency upon any building control technology being rendered inoperable"; (c) address "whether the notice trigger should depend upon the duration of BCT inoperability and whether the notice requirement should vary depending upon the type of BCT at issue"; and (d) provide revised BCT maintenance conditions for school site NFR Letters. (Order at 47-48)

The Illinois EPA regards building control technologies used as institutional controls to address the indoor inhalation exposure route the same as engineered barriers, construction worker safety precautions, property use restrictions such as industrial/commercial land use, and groundwater use restrictions that area used as institutional controls to address the other exposure routes, i.e., soil ingestion, outdoor inhalation, and groundwater ingestion. Institutional controls relied upon in obtaining a No Further Remediation Letter are investigated during post-NFR follow-up inspections. Therefore, sites that rely on building control technologies to obtain an NFR Letter will be added to the routine post-NFR follow-up inspections.

In lieu of including the sentence suggested by the Board "For a school, the site owner/operator shall notify the Agency upon any building control technology being rendered inoperable," the Illinois EPA recommends including a sentence such as the following: "For a school, the site owner/operator shall notify the Agency, the school board, and every parent or legal guardian for all enrolled students when a building control technology is rendered inoperable for a period of five days over any six month period." This would account for a chronic, not acute, exposure scenario given that a building must be fit for human occupancy for

at least six consecutive months. Additionally, requiring that notice also be provided to the school board and parents or guardians of enrolled students provides these stakeholders with the necessary information so that they can take prompt and appropriate action at the local level to address the problem. If the site owner/operator fails to comply with the requirements of the NFR Letter, the Illinois EPA may void the NFR Letter.

The Illinois EPA does not recommend specific BCT maintenance conditions for school sites. Building maintenance is a routine function at schools and is typically done during the school breaks when children are not present. The scheduling of building maintenance, including BCT service and repair, should be left up to the individual schools.

- 11. The Board has proposed that the definition of "school" found in 35 Ill. Adm. Code 740.800(b) (from the Site Remediation Program rules) be carried over into Part 742. (Order at 48) The Illinois EPA finds the addition of this definition in Part 742 to be acceptable.
- 12. The Board proposed amendments to the ELUC form found in Appendix F to include references to account for soil gas and indoor inhalation BCTs. (Order at 49) The Illinois EPA concurs with those amendments.
- 13. The Board expressed concern regarding sites that have already completed the remediation process (prior to site reuse as a school) and have been issued an NFR Letter but have not addressed the indoor inhalation pathway. The Board stated that it "finds that it would be prudent for IEPA to promptly notify these schools about the new indoor inhalation exposure route and the manner in which that pathway might be addressed." (Order at 51)

The Board specifically requested that the Illinois EPA (a) "include a list of all schools in Illinois to which NFR Letters have been issued or which are subject to an ELUC, indicating which of those sites, if any, have already directly addressed the indoor inhalation exposure

route"; and (b) include every "school" as that word is defined in SRP (35 Ill. Adm. Code 740.800(b)), including both SRP and the Leaking UST Programs, and any school issued a 4(y) release.

The voluntary Site Remediation Program does not identify schools as a unique field in the Illinois EPA's database; thus, it's questionable whether all school sites are identified on the attached list (See Exhibit B). Prospective sites were selected by filtering the site name, site owner, and remediation applicant fields for the terms "school," "university," "college," "academy," "education," or "public building commission." The type of site field was also filtered for the value "school." The Public Building Commission sites were included because most are developed as schools; however, some of these sites were intended as police district headquarters or engine companies and were deleted. Sites remaining on the list as either named, owned by, or enrolled by the Public Building Commission may or may not be school sites but are likely to be. Additionally, businesses that met the selection criteria but that were not a school, such as the College Inn (a motel), were deleted from the list. Finally, schools that meet the regulatory definition of a school have been tracked since April 25, 2002 when the requirements for schools were added to the regulations in 35 Ill. Adm. Code 740, Subpart H. Please note that based on the definition of "school" found in Section 740.800(b), this list contains significantly more sites than the definition encompasses.

A search of the Leaking UST Program's database indicated that 423 probable school sites have received NFR Letters (See Exhibit C). The search criteria were as follows: any site with (1) "school" in its name; and (2) an NFR Letter or 4(y) letter. Therefore, the list includes sites that met the cleanup requirements prior to the adoption of the TACO regulations (July 1, 1997). The Illinois EPA cannot guarantee that all schools, as defined in 35 Ill. Adm. Code 740, have

been identified because it is conceivable that a school might have entered the program under a different name. Furthermore, the Illinois EPA cannot identify whether a school adjacent to a Leaking UST site would have entered into an agreement with the tank owner or operator to accept institutional controls (i.e., an Environmental Land Use Control) because this information is not tracked in the database.

The Board's proposition to notify schools individually of the addition of the indoor inhalation exposure route to TACO is problematic for the following reasons: (1) the Illinois EPA cannot assure every school is on the list; (2) the chemicals of concern at the school site may not be volatile chemicals; (3) volatile chemicals that are present may not be in the area of a building where children attend classes; and (4) the original cleanup may have already addressed the pathway.

The Illinois EPA therefore suggests that we notify schools about the new indoor inhalation exposure route through the State Board of Education and other statewide educational organizations by distributing fact sheets that contain information about the new pathway and how the pathway might be addressed. This information will also be posted on the Illinois EPA's website.

WHEREFORE, the Illinois EPA submits its First Notice Comments for the Board's consideration.
