
**HEARING OFFICER ORDER**

On June 7, 2012, all parties participated in a telephonic status conference with the hearing officer. The petitioner stated that since the last status conference, it has had a lengthy conference with the Illinois Environmental Protection Agency (Agency) regarding the draft adjusted standard and the Agency has suggested revisions. At present, the petitioner is reviewing those suggested revisions. It is anticipated that once approved, the petitioner will file an adjusted standard petition that may moot the above-captioned appeal. The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including December 20, 2012.

By agreement, the record in this matter is now due to be filed on or before September 24, 2012.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on August 9, 2012, at 11:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


