
HEARING OFFICER ORDER

On June 18, 2012, all parties participated in a telephonic status conference. The parties were directed to serve any discovery on or before June 22, 2012. Responses due on or before July 20, 2012. The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including November 15, 2012.

On June 8, 2012, the respondent filed a motion for leave to file a reduced number of copies of the administrative record for each of the above appeals. The motion requests that the respondent be given leave to file an original and a copy along with 7 CD discs in lieu of the required original and nine hard copies. Petitioner has no objection. Respondent's motion is granted.

The parties or their legal representatives are reminded and directed to appear at a telephonic status conference with the hearing officer on July 19, 2012, at 9:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


