
HEARING OFFICER ORDER

On July 2, 2012, the parties submitted a proposed discovery schedule for the supplemental hearing in this matter. It is noted that the tentative hearing date is on or about September 20, 2012.

The proposed discovery schedule is accepted to the extent as follows: Disclosure of all witnesses who will testify at the supplemental hearing, including expert and opinion witnesses on or before August 9, 2012; Completion of all depositions on or before August 31, 2012; Completion of depositions and close of discovery on September 6, 2012; All pre-hearing motions, including motions *in limine*, must be filed on or before September 7, 2012; All responses to pre-hearing motions, including motions *in limine*, must be filed on or before September 13, 2012; Exchange of exhibits and witness lists on or before September 13, 2012; Complainant's post-hearing brief must be filed on or before October 23, 2012; Respondent's post-hearing brief must be filed on or before November 13, 2012; Complainant's reply, if any, must be filed on or before November 27, 2012. Record closes on December 4, 2012.

The parties or their legal representatives are directed to appear at a telephonic status conference on July 12, 2012, at 1:00 p.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance.
