**RESPONSE TO THE ILLINOIS
POLLUTION CONTROL BOARD'S JUNE 21, 2012 ORDER**

NOW COMES Petitioner, THE PREMCOR REFINING GROUP INC.

("Premcor"), by and through its attorneys, HODGE DWYER & DRIVER, in response to the Illinois Pollution Control Board's ("Board") Order of the Board, dated June 21, 2012 ("Order"). Premcor responds to the Board's Order as follows:

1. Premcor received the Board's Order directing the parties to provide evidence and argument on the issue of a timely request for a 90-day extension for appeal of a January 13, 2012, Illinois Environmental Protection Agency ("Agency") determination.

2. Premcor has reviewed its file regarding this matter pursuant to the Board's Order. In particular, Premcor has reviewed documentation relative to the Agency's February 7, 2012 letter that was attached and submitted to the Board in Petitioner's PETITION FOR REVIEW OF AGENCY DECISION REGARDING RESPONSE ACTION PLAN FOR GROUNDWATER INWARD GRADIENT CONTROL, as Petitioner's Exhibit B.

3. Premcor does not have any evidence indicating that the February 7, 2012 letter was submitted to the Board, in accordance with Section 40 of the Illinois Environmental Protection Act and/or 35 Ill. Admin. Code §§ 105.206 and 105.208.
