**NOTICE OF WAIVER OF  
120-DAY DECISION DEADLINE**

NOW COMES Petitioner, VESUVIUS USA CORPORATION (hereinafter "Petitioner"), by and through its attorneys, HODGE DWYER & DRIVER, pursuant to 35 Ill. Admin. Code § 101.308(c)(2), and hereby agrees to waive the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board in this proceeding until January 11, 2013. In support of this Notice, Petitioner states as follows:

1. On March 3, 2008, Petitioner filed a Petition for Review of the Federally Enforceable State Operating Permit issued to Petitioner by the Illinois Environmental Protection Agency on January 28, 2008.
2. On March 24, 2008, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline for an Additional 90 Days, or until September 17, 2008.
3. On May 27, 2008, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline for an Additional 90 Days, or until December 3, 2008.
4. On July 24, 2008, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline until February 19, 2009.

5. On November 19, 2008, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline until May 21, 2009.
6. On February 5, 2009, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline until August 20, 2009.
7. On April 14, 2009, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline until November 19, 2009.
8. On July 23, 2009, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline until February 18, 2010.
9. On November 23, 2009, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline until May 6, 2010.
10. On January 26, 2010, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline until July 15, 2010.
11. On March 25, 2010, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline until October 7, 2010,
12. On May 25, 2010, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline until December 16, 2010.
13. On September 29, 2010, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline until March 17, 2011.
14. On December 2, 2010, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline until May 19, 2011.
15. On February 4, 2011, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline until July 21, 2011.

16. On April 18, 2011, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline until October 6, 2011.

17. On June 14, 2011, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline until December 15, 2011.

18. On August 17, 2011, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline until August 23, 2012.

19. On May 9, 2012, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline until October 31, 2012, which is the current deadline.

20. Petitioner hereby voluntarily agrees to waive the statutory 120-day decision deadline until January 11, 2013, in order to conduct settlement negotiations in this matter.
