1. This Petition For Review is filed pursuant to the provisions of Section 31.1 of the Illinois Environmental Protection Act, 415 ILCS 5/31.1 (2010).
2. On June 18, 2012 the Respondent was served with an Administrative Citation alleging that Respondent has violated Section 21 (p), (1), (3), (5) & (7), and § 5/55 (k)(1) of the Illinois Environmental Protection Act, 415 ILCS 5/21 (p) (1), (3), (5) & (7), and 5/55 (k)(1) (2010).
3. The Administrative Citation was improperly issued to Respondent for one or more of the following reasons:
 - A. The Respondent did not cause or allow the alleged violations.
 - B. The alleged violations were the result of uncontrollable circumstances.


