

Dear Honorable Members of the Illinois Pollution Control Board,

My name is Johnny Adams and I am the owner of J. Adams Construction in Joppa, Illinois. I'm writing to share my support for Ameren Energy Resources Company, LLC and its request to extend the deadline for upgrading its power stations to meet new state emission standards.

The Ameren Energy Resources Company, LLC (AER) Joppa Power Plant has long played a vital role in our economy. The company provides hundreds well-paying jobs for the state and the property tax it generates goes toward local public services, like our schools, parks and libraries. In today's challenging economy and high unemployment, we need all the help we can get.

I understand the necessity of regulating power plant emissions in the state.
