HEARING OFFICER ORDER

On July 26, 2012, all parties participated in a telephonic status conference with the hearing officer. The parties' attorneys stated that they continue to have discussions regarding language in a draft permit and that they anticipate actually drafting a permit in the near future. The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including February 21, 2013.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on November 15, 2012, at 1:30 p.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




