
HEARING OFFICER ORDER

On August 9, 2012, all parties participated in a telephonic status conference with the hearing officer. The petitioner stated that since the last status conference, it appears the Illinois Environmental Protection Agency has completed a revised adjusted standard but continues to be reviewed internally. The petitioner is hopeful that the adjusted standard will be approved by the next status conference. It is anticipated that once approved, the petitioner will file an adjusted standard petition that may moot the above-captioned appeal. The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including February 21, 2012.

By agreement, the record in this matter is now due to be filed on or before November 21, 2012.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on October 18, 2012, at 11:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


