NOW COMES the Complainant, the Illinois Environmental Protection Agency ("Illinois EPA"), by and through its attorney, Assistant Counsel Michelle M. Ryan, pursuant to 35 Ill. Adm. Code 108.402, and respectfully states as follows:

- On July 16, 2012, the Illinois EPA issued an Administrative Citation to Respondent Dennis Zindars, based on an inspection conducted on June 6, 2012.
- Attempts to serve the Administrative Citation, by the Illinois EPA's Champaign Regional
  Office, were unsuccessful.
- Because Dennis Zindars was not timely served within 60 days as required by 415 ILCS
  5/31.1(b), this Administrative Citation should be dismissed.

WHEREFORE, the Illinois Environmental Protection Agency requests that the Board dismiss the pending action against Dennis Zindars.
