#### PETITIONER'S FIRST REQUEST FOR PRODUCTION OF DOCUMENTS

Now comes Petitioner, Martin Maggio ("Maggio"), by his attorneys, Jeep & Blazer, LLC, and pursuant to 35 IADC 101.616, hereby requests that Respondents produce the documents requested herein at the offices of Jeep & Blazer, L.L.C., 24 N. Hillside Avenue, Suite A, Hillside, Illinois 60162 on or before October 12, 2012.

#### **DEFINITIONS AND INSTRUCTIONS**

Α. "Winnebago County" shall refer to and include Winnebago County, Illinois, the Winnebago County Board, and their elected officials, agents, employees, instrumentalities and agencies.

B. "WLC" shall refer to and include Winnebago Landfill Company, LLC and its officers, members, managers, agents, employees and attorneys.

C. "Application" shall refer to Site Location Application filed on January 17, 2012 by WLC for the expansion of WLC's existing municipal solid waste landfill located North of Edson Road and West of U.S. Interstate 39 in Southern Winnebago County.

D. "Hearing" shall refer to the public hearing on the Application commenced on April 23, 2012 and closed on April 30, 2012.

E. Whenever reference is made to any person or entity by name, such reference shall be deemed to include all of the person's or entity's agents, employees or attorneys and the entity's subsidiaries, affiliates, merged, consolidated or acquired predecessors, divisions and holding or parent companies and includes present and former officers, directors, shareholders, agents, employees and attorneys.

F. "Documents" shall include all written material or other tangible medium of reproduction of every kind or description, however produced or reproduced, including, without limitation, correspondence, notes, memoranda, recordings, photographs, letters, financial statements, tax returns, bank account statements, specifications, inspection reports, blueprints, drawings, diagrams, charts, summaries, computer printouts, computer data, microfilm, microfiche, records of oral conversations, diaries, calendars, field reports, logs, job minutes, job meetings, analyses, projections, work papers, tape recordings, films, video tapes, models, statistical statements, graphs, laboratory and engineering reports and notebooks, plans, minutes or records of meetings, minutes or records of conferences, lists of persons attending meetings or conferences, reports and/or summaries of investigations, opinions, or reports of consultants, appraisals, evaluations, records, contracts, agreements, leases, invoices, receipts, preliminary drafts, however denominated, by whomever prepared, to whomever addressed, which are in possession of the respondent as defined herein. Further, "documents" includes any copies of documents which are not identical duplicates of originals, including, but not limited to, all drafts of whatever date and copies with typed or handwritten notations, and any other form of reporting, storing, maintaining or indexing such information,

including, without limitation, electronic storage, computer storage, shorthand notes, diagrams, magnetic cards and other forms of storage.

G. "Relating to or reflecting" shall refer to documents that contain or refer in any way, directly or indirectly, to or in any legal, logical or factual way connected with a paragraph of any document of this Request.

H. "Person" includes any individual, corporation, trust, and any other collective organization or entity unless the context clearly indicates reference to an individual person.

I. Wherever appropriate herein, the singular form of a word should be interpreted to include the plural, and vice versa.

J. As used herein, "and" as well as "or" should be considered either disjunctively or conjunctively as necessary to bring within the scope of this Request any documents which might otherwise be construed to be outside its scope.

K. In producing documents responsive to this Request, you are requested to indicate for which paragraph each document is responsive.

L. If any document requested by this Request has been destroyed, mutilated, altered, redacted, or discarded, that document must be identified by stating:

- (1) The name and address of the sender of the document;
- (2) The name and address of the author of the document;
- (3) The name and address of all entities to whom the document was addressed;
- (4) The name and address of all entities to whom a copy of the document was sent;

- (5) The name and address of all entities known to Defendants who had seen the document or participated in communications about the document;
- (6) The job title of each entity listed in (1) through (5) above;
- (7) The name and address of all entities known to Defendants who have received or currently possess a copy of the document;
- (8) The date of the document;
- (9) The date of destruction, alteration, mutilation, redaction, or discard of the document, manner of destruction, alteration, mutilation, redaction, or discard of the document, and reasons for destruction, alteration, mutilation, redaction, or discard of the document;
- (10) A brief description of the nature and subject of the document; and
- (11) The entity authorizing and performing the destruction, alteration, mutilation, redaction, or discard of the document.

M. If you object to any of the definitions or instructions herein, or to any of these specific requests herein, state in writing each objection and the grounds thereof.

N. You are requested to produce an affidavit stating whether the production is complete in accordance with this Request.

O. This Request shall be deemed continuing so as to require prompt, further and supplemental production if you obtain possession of documents responsive to any request herein.

P. If you assert that any document called for by this request is privileged, you shall provide the following information with respect to each document:

- (1) Its date;
- (2) Its author;

- (3) All addresses of recipients of the original or copies thereof;
- (4) A brief description of its subject matter and physical size; and
- (5) The nature of the privilege claimed.

#### AFFIDAVIT OF COMPLIANCE WITH 415 ILCS 5/39.2(b)

GEORGE MUELLER, being first duly sworn on oath, deposes and states as follows:

1. I am an attorney licensed to practice in the State of Illinois with my principal office located at 609 E. Etna Road, Ottawa, Illinois, 61350.

2. I am one of the attorneys for Winnebago Landfill Company, LLC, and it was my responsibility to prepare, publish and serve pre-filing notices as required in 415 ILCS 5/39.2(b).

3. 415 ILCS 5/39.2(b) requires that no later than fourteen (14) days prior to a request for location approval of a pollution control facility, the applicant shall cause written notice of such request to be served either in person or by registered mail, return receipt requested, on the owners of all property within the subject area not wholly owned by the applicant and on the owners of all property within 250 feet in each direction of the lot line of the subject property, said owners being such persons or entities which appear from the authentic tax records of the county in which such facility is to be located, provided, that the number of all feet occupied by all public roads, streets, alleys and other public

ways shall be excluded in computing the 250 feet requirement, provided further that in no event shall this requirement exceed 400 feet, including public streets, alleys and other public ways. Section 39.2(b) further provides that such notice shall be served upon members of the general assembly from the legislative district in which the proposed facility is located and shall be published in a newspaper of general circulation published in the county in which the site is located. Section 39.2(b) further provides that such notice shall state the name and address of the applicant, the location of the proposed site, the nature and size of the development, the nature of the activity proposed, the probable life of the proposed activity, the date when the request for site approval will be submitted, and a description of the right of persons to comment on such request.

4. The Notice prepared and served in connection with the aforesaid requirement is attached hereto and made a part hereof as Exhibit A. Said Notice conforms to the requirements of Section 39.2(B).

5. I identified the names and address of all members of the General Assembly from the legislative district in which the proposed facility is located by using information publically maintained and available on the Illinois General Assembly internet website www.ilga.gov.

6. I caused a copy of the Notice to be published in the Rockford Registered Star, a newspaper of general circulation in the county in which the application is pending on December 28, 2011. A copy of the actual publication and proof of publication is attached hereto and made a part hereof as Exhibit B.

On December 13, 2011, I searched the authentic tax records in 7. Winnebago County and Ogle County to ascertain the names and addresses of all owners of the subject property and all other property within 400 feet of the subject property. In Winnebago County, I first visited the office of the Treasurer and was advised that the County Treasurer, the County Supervisor of Assessments, and the County Recorder jointly maintain a consolidated computer database of the authentic tax records of the County. I was told that this database is generally updated daily. I was also provided with plat books, section maps and line drawings which enabled me to accurately identify the parcel index numbers of properties in proximity to the subject property. I was provided access to a computer in the County Recorder's office to access the consolidated database of authentic records for the purpose of identifying owner names and addresses associated with the parcel identification numbers. The process in Ogle County was essentially the same, and County also has a consolidated computer database of official tax records maintained and updated on a daily basis. The only difference in the Ogle County process was that Ogle County also has a GIS department which maintains online maps from which the parcel identification numbers of adjoining properties could be identified without having to access hard copies of plat books or section maps.

8. Attached hereto and made a part hereof as Exhibit C is the full and complete list of all individuals and entities which were sent pre-filing Notice pursuant to 415 ILCS 5/39.2(b). This includes all owners of property and members of the General Assembly who were entitled to Notice.

9. On December 27. 2011, I caused the consolidated computer databases of official tax records in Winnebago County and Ogle County to be searched again to ascertain whether there had been any changes or additions since my previous search.

10. On December 26 and December 27, 2011, certified mail Notice was sent to all individuals and entities set forth on Exhibit C. Copies of the certified mail receipts for all of these Notices are attached hereto and made a part hereof as Exhibit D.

11. The siting application herein was filed on January 17, 2012.

12. All of the foregoing complies fully and completely with the pre-filing notice requirements of 415 ILCS 5/39.2(b).

#### NOTICE OF INTENT TO FILE A REQUEST FOR LOCAL SITING APPROVAL OF A NEW POLLUTION CONTROL FACILITY WITH THE COUNTY OF WINNEBAGO

YOU ARE HEREBY NOTIFIED, pursuant to Section 39.2(b) of the Illinois Environmental Protection Act ("the Act"), 415 ILCS 5/39.2(b), that the Applicant, Winnebago Landfill Company, LLC ("WLC"), whose address is 5450 Wansford Way, Suite 201, Rockford, IL., 61109, will file its request for siting approval for a new pollution control facility with the County of Winnebago, 404 Elm Street, Rockford, Illinois 61101, on January 17, 2012. In its request the Applicant will seek approval to site, construct, expand and operate the Winnebago Landfill located generally across from WLC's landfill office at 8403 Lindenwood Road, Rockford, Illinois 61109, east of Ill. Rte. 251, west of US Interstate 39 and north of Edson Rd. The Applicant will seek approval to laterally expand the existing sanitary landfill facility to the east.

The proposed expansion would increase the permitted disposal area (i.e., the waste footprint) from 196.81 acres to 419.19 acres on a total site of 797.387 acres (the present site being 433.47 acres). The proposed expansion would have a maximum height of 1002 feet msl.

The proposed facility would be a non-hazardous solid waste landfill. The Applicant will develop and operate a modern, secure sanitary landfill for the disposal of municipal solid waste and non-hazardous special waste, only as approved by the Illinois Environmental Protection Agency and other regulatory



agencies or as authorized by statute. The waste accepted for disposal will be general municipal waste generated by residential, commercial and industrial sources and construction and demolition debris. The proposed facility has a projected life of approximately 25 years after start-up, which is projected to occur

in 2020.

Copies of the request or any part thereof will be available from the Winnebago County Clerk upon payment of the actual cost of reproduction, as outlined in the Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*)

The County of Winnebago must hold at least one public hearing no sooner than 90 days but no later than 120 days from its receipt of the Request for Siting Approval. Notice by publication of such hearing will be provided. You may appear at the hearing and may participate in the proceedings provided you register with the Winnebago County Clerk as a party to the proceeding prior to the commencement of the hearing. Any person may also file written comments with the Winnebago County Clerk or make oral public comment at the public hearing concerning the appropriateness of the proposed site for its intended purpose. The Winnebago County Board shall consider any comment received or postmarked from the date of acceptance of the application through and until thirty (30) days after the date of the last public hearing. Said written comments shall

be mailed or delivered to the Winnebago County Clerk, 404 Elm Street, Rockford, Illinois 61101. For further information concerning the hearing procedures and your right to participate and comment, please consult the Act (415 ILCS 5/39.2) and Article II of the Chapter 42 of the Winnebago County Code, as amended, as well as the rules and procedures for the conduct of such public hearings established by the County Board.
