### **JURISDICTION**

This Administrative Citation is issued pursuant to the authority vested in the Illinois Environmental Protection Agency by Section 31.1 of the Illinois Environmental Protection Act, 415 ILCS 5/31.1 (2010).

### <u>FACTS</u>

- 1. That David Chapman is the current operator ("Respondent") of a facility located at the north end of Stemme Street, Wilsonville, Macoupin County, Illinois. The property is commonly known to the Illinois Environmental Protection Agency as Wilsonville/Chapman.
- 2. That said facility is an open dump operating without an Illinois Environmental Protection Agency Operating Permit and is designated with Site Code No. 1171205002.
  - 3. That Respondent has operated said facility at all times pertinent hereto.
- 4. That on July 19, 2012, Mark Weber of the Illinois Environmental Protection Agency's ("Illinois EPA") Springfield Regional Office inspected the above-described facility. A copy of his inspection report setting forth the results of said inspection is attached hereto and made a part hereof.

5. That on <u>9-14-12</u>, Illinois EPA sent this Administrative Citation via Certified Mail No. Hand delinery

### VIOLATIONS

Based upon direct observations made by Mark Weber during the course of his July 19, 2012 inspection of the above-named facility, the Illinois Environmental Protection Agency has determined that Respondent has violated the Illinois Environmental Protection Act (hereinafter, the "Act") as follows:

- (1) That Respondent caused or allowed the open dumping of waste in a manner resulting in litter, a violation of Section 21(p)(1) of the Act, 415 ILCS 5/21(p)(1) (2010).
- (2) That Respondent caused or allowed the open dumping of waste in a manner resulting in open burning, a violation of Section 21(p)(3) of the Act, 415 ILCS 5/21(p)(3) (2010).

### CIVIL PENALTY

Pursuant to Section 42(b)(4-5) of the Act, 415 ILCS 5/42(b)(4-5) (2010), Respondent is subject to a civil penalty of One Thousand Five Hundred Dollars (\$1,500.00) for each of the violations identified above, for a total of <u>Three Thousand Dollars (\$3.000.00)</u>. If Respondent elects not to petition the Illinois Pollution Control Board, the statutory civil penalty specified above shall be due and payable no later than <u>October 1, 2012</u>, unless otherwise provided by order of the Illinois Pollution Control Board.

If Respondent elects to contest this Administrative Citation by petitioning the Illinois Pollution Control Board in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1 (2010), and if the Illinois

Pollution Control Board issues a finding of violation as alleged herein, after an adjudicatory hearing, Respondent shall be assessed the associated hearing costs incurred by the Illinois Environmental Protection Agency and the Illinois Pollution Control Board. Those hearing costs shall be assessed in addition to the One Thousand Five Hundred Dollar (\$1,500.00) statutory civil penalty for each violation.

Pursuant to Section 31.1(d)(1) of the Act, 415 ILCS 5/31.1(d)(1) (2010), if Respondent fails to petition or elects not to petition the Illinois Pollution Control Board for review of this Administrative Citation within thirty-five (35) days of the date of service, the Illinois Pollution Control Board shall adopt a final order, which shall include this Administrative Citation and findings of violation as alleged herein, and shall impose the statutory civil penalty specified above.

When payment is made, Respondent's check shall be made payable to the Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal Services, Illinois Environmental Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Along with payment, Respondent shall complete and return the enclosed Remittance Form to ensure proper documentation of payment.

If any civil penalty and/or hearing costs are not paid within the time prescribed by order of the Illinois Pollution Control Board, interest on said penalty and/or hearing costs shall be assessed against the Respondent from the date payment is due up to and including the date that payment is received. The Office of the Illinois Attorney General may be requested to initiate proceedings against Respondent in Circuit Court to collect said penalty and/or hearing costs, plus any interest accrued.

### PROCEDURE FOR CONTESTING THIS ADMINISTRATIVE CITATION

Respondent has the right to contest this Administrative Citation pursuant to and in accordance with Section 31.1 of the Act, 415 ILCS 5/31/1 (2010). If Respondent elects to contest this Administrative Citation, then Respondent shall file a signed Petition for Review, including a Notice of Filing, Certificate of Service, and Notice of Appearance, with the Clerk of the Illinois Pollution Control Board, State of Illinois Center, 100 West Randolph, Suite 11-500, Chicago, Illinois 60601. A copy of said Petition for Review shall be filed with the Illinois Environmental Protection Agency's Division of Legal Counsel at 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Section 31.1 of the Act provides that any Petition for Review shall be filed within thirty-five (35) days of the date of service of this Administrative Citation or the Illinois Pollution Control Board shall enter a default judgment against the Respondent.

On July 19, 2012 Mr. Mark Weber, Division of Land Pollution Control/Field Operations Section (DLPC/DOS) - Springfield Regional Office (SRO), conducted a re-inspection of the Chapman site in Wilsonville, Illinois. The site was initially referred to the Illinois Environmental Protection Agency (IEPA) via a complaint which indicated the respondent was hauling bags of trash to the subject property where they were being allowed to accumulate. The initial IEPA inspection of the Chapman site was conducted on April 23, 2008 as a result of the complaint.

The Chapman site can be found at the north end of Stemme Street in Wilsonville, Illinois per the attached Macoupin County GIS and other aerial photos. Legally and specifically the property is located in the Southeast Corner of the North Half of Southwest Quarter of Section Numbered Three, Township Numbered Seven (7) North, Range Numbered Seven (7) West of the Third Principal Meridian in the County of Macoupin and the State of Illinois. This legal description was obtained from a Quit Claim Deed filed with the Macoupin County Recorder's Office on June 14, 1988. The owner on the deed is listed as David Chapman. Per the GIS photos, the address for the property was given as 203 North Stemme in Wilsonville, Illinois. Mr. Chapman maintains his primary residence at this address.

At the time of the initial April 23, 2008 inspection a relatively small volume of open dumped waste was observed at the Chapman site. The total volume was estimated at 5 cubic yards at that time. Open dumped wastes included carpet, plastics, insulation, dimensional lumber, aluminum cans, and closed/sealed trash bags. Almost all of the open dumped waste was found around a roll-off box located on the Chapman property. The roll-off box itself was empty at the time of the inspection. The IEPA inspector also observed two burn barrels located along the drive. One of the barrels was filled with landscape debris and the other with paper, cardboard, and landscape debris. The IEPA inspector did not observe any evidence that the open burning of waste on the ground.

The IEPA inspector also observed approximately 150 used tires located behind and to the north of the roll-off box. Upon returning to the office the inspector left a phone message

for Mr. Chapman informing him of an upcoming IEPA sponsored used tire collection taking place in White Hall, Illinois. Mr. Christ Chapman, David's brother, returned the call stating that the used tires would be hauled to the collection. A Consensual Removal Agreement (CRA) was signed by Mr. Chapman on April 25, 2008 indicating that 105 tires had been taken to the Greene County used tire collection in White Hall.

A follow-up inspection of the Chapman site was conducted on May 28, 2008 to determine that the used tires had been removed. The IEPA inspector met with and interviewed the Chapman brothers at that time. David Chapman stated that he was licensed by the Village of Wilsonville to provide waste hauling services at a fee to some Wilsonville residents. These wastes were emptied into the aforementioned roll-off box located at the property. The roll-off box was then emptied once a week by Allied Waste for disposal at an area landfill. Solid wastes such as dimensional lumber and carpet were open dumped in the immediate vicinity of the roll-off box due to the fact that it had been filled beyond capacity. Metal was being segregated from the solid waste by the Chapman brothers, accumulated and stored on-site, and hauled to an area scrap yard approximately once every 2 – 3 months. This inspector spoke with the Mayor of Wilsonville following the re-inspection. According to the Mayor, the Village of Wilsonville has not issued a permit or license to Mr. Chapman for waste hauling.

As a result of the two inspections a Violation Notice (VN) dated June 4, 2008 was sent to Mr. David Chapman. Violations of the Illinois Environmental Protection Act cited in the VN included Sections 21(a), 21(d)(1), 21(d)(2), 21(e), 21(p)(1), and 55(a)(1). Apparent violations of the Regulations, 35 Illinois Administrative Code (IAC) 812.101(a), 807.201, and 807.202(a) were also cited, with the latter 2 violations being cited for operating a transfer station without IEPA permits. Mr. Chapman was given a deadline of August 15, 2008 to address the violations at his property cited in the VN.

### July 19, 2012 Re-Inspection

The IEPA inspector arrived at the Chapman site at approximately 0920 hours on July 19, 2012. The temperature was approximately 80° Fahrenheit. Skies were cloudy and overcast with a 5-10 mile per hour southeast wind. Soil conditions were dry. The responsible party was not home at the time of the inspection.

Based upon observations made by the IEPA inspector during the July 19, 2012 inspection it appears that site conditions have actually worsened since the April 23 and May 28, 2008 inspections. There is now a greater volume of open dumped waste at his property. Open dumped wastes are located all throughout the site. Wastes open dumped on-site include white goods, carpet, air conditioning units, buckets of paint, furniture, insulation, windows and doors, plastics, inoperable mowers, mixed metals, dimensional lumber, and landscape waste. It appears that Mr. Chapman is removing materials from wastes hauled to the site that are recyclable and disposing of some of the non-recyclable wastes in a large dumpster that remains on-site and on the ground. The dumpster is surrounded on 3 sides by a tall fence, and exceeds the size of most residential refuse containers.

The IEPA inspector also observed and documented approximately fifteen 5 five gallon metal and plastic buckets located on-site. All of the buckets had lids, and nearly all of them were full. Most of the buckets were marked as paint, but a few were clearly placarded as containing flammable liquids. Those buckets contained no further markings that would identify the contents within. Their origin or whether or not they had useable contents could not be determined.

It appears that open burning is occurring on-site as well, likely to obtain metal for scrap. The IEPA inspector observed and documented box springs, mattresses, and car seats where the cover material and padding had been burned away. An open burn area is located immediately northwest of the residence. At the time of the re-inspection there was a 20 cubic yard waste pile located within the burn area composed of landscape waste, wallboard, carpet, dimensional lumber, paper, glass, and mixed metals. All of the materials located within that particular waste pile are fairly combustible. It was also evident that open burning has occurred at this particular location in the past. The IEPA inspector observed ash located under the open dumped wastes and the vegetation in this area had been burned away. The total volume of open dumped waste on-site is estimated at 100 cubic yards. Please refer to the attached photographs for depictions of site conditions as they existed during the July 19, 2012 re-inspection.

Photograph #1 depicts a pile of dimensional lumber and assorted metals.

Photograph #2 provides a view of one of two vehicles parked on-site. Both had current registration.

Photograph #3 is of a second vehicle parked on-site. The registration was current. Some of the dimensional lumber and metal shelving units stored on-site can be seen as well.

Photograph #4 was taken of a large dumpster located on-site. It appears that Mr. Chapman is taking in wastes that he feels can be recycled and putting at least some of the wastes that cannot be reused in the dumpster or on the ground.

Photograph #5 shows some of the open dumped wastes located in proximity of the dumpster. Wastes in this area include mixed metals, plastics, furniture, and glass.

Photograph #6 depicts windows and doors stacked alongside the dumpster.

Photograph #7 is of roughly fifteen 5 five gallon metal and plastic buckets located onsite. All of the buckets had lids, and nearly all of them were full.

Photograph #8 shows that most of the buckets were marked as paint but a few were clearly placarded as containing flammable liquids.

Photograph #9 shows more of the windows and dimensional lumber open dumped onsite. Also visible are bags of insulation some of which have broken open.

Photograph #10 provides a better view of the bags of insulation open dumped on-site.

Photograph #11 provides a view of some of the mixed metals and windows located on site. The rusty metals located in the foreground are the remnants of a sleeper sofa and mattress. The cover material and padding have been burned off.

Photograph #12 is of a white good, rolled wire fencing, and an air conditioning unit open dumped on-site.

Photograph #13 provides another view of some of the wastes open dumped on-site. Plastics, glass, mixed metals, and an inoperable riding mower are all visible.

Photograph #14 shows a significant waste pile composed of landscape waste, wallboard, dimensional lumber, paper, glass, and mixed metals open dumped in the location of an inactive open burn area. The box spring in the foreground has had the cover material and padding burned away.


Photograph #15 depicts a car seat from which the non recyclable materials have been burned away.

Photograph #16 is of carpet, dimensional lumber, paper, glass, and mixed metals all open dumped on-site. Open burning has occurred in this particular location in the past. There is ash located under the open dumped wastes and the vegetation has been burned away.

The July 19, 2012 re-inspection of the Chapman site was conducted in order to determine if violations cited in the January 20, 2011 VN had been rectified. It was determined that while some of the open dumped waste has been removed per the conditions of the VN, violations of the Illinois Environmental Protection Act persist. Violations of the Act that were observed during the re-inspection include Sections: 9(a), 9(c), 21(a), 21(d)(1), 21(d)(2), 21(e), 21(p)(1), and 21(p)(3). Apparent violations of the Regulations, 35 Illinois Administrative Code (IAC) Sections 807.201, 807.202, and 812.101(a) exist as well. Refer to the attached Open Dump Checklist for additional information.

The IEPA inspector left the Chapman site at approximately 0945 hours and returned to IEPA headquarters in Springfield, Illinois.




