HEARING OFFICER ORDER

On September 20, 2012, the Board proposed amendments to Part 809 of its solid waste and special waste hauling regulations for first-notice publication in the *Illinois Register* without commenting on their substantive merits. *See* 35 Ill. Adm. Code 809. The Board proposed to implement a provision of Public Act 97-1081, effective August 24, 2012, amending Section 22.2(l) of the Environmental Protection Act (Act) by extending the duration of special waste hauling permits from one year to three years. *See* 415 ILCS 5/22.2(l) (2010); Public Act 97-1081. The Board proposed to amend 35 Ill. Adm. Code 809.212 (Duration of Special Waste Hauling Permits) to make it consistent with this statutory revision. The Board also proposed to amend 35 Ill. Adm. Code 809.204(a) (Applications for Special Waste Hauling Permit - Filing

in compliance with the Americans with Disabilities Act and other applicable federal and State laws, the hearing will be accessible to individuals with disabilities. and Final Action by the Agency) to clarify that special waste hauling permit application fees are established by statute.

The Board will conduct two hearings in order to allow the Agency and any other interested participants the opportunity to present testimony on the merits and economic impact of the proposal. See 415 ILCS 5/28(a) (2010). At hearing, all persons wishing to testify will be sworn in and subject to questioning. 35 Ill. Adm. Code 102.424(f), 102.428(a), (b). The Board will also receive any testimony on any economic impact study (EcIS) conducted by the Department of Commerce and Economic Opportunity (DCEO) on the proposed rules or on DCEO's decision not to perform an EcIS. See 415 ILCS 5/27(b) (2010).

Pre-Filing Deadlines

Participants who intend to testify at hearing are urged to pre-file their testimony and are directed to serve any pre-filed testimony on all persons on the Service List. See 35 Ill. Adm. Code 102.424(c). Before filing pre-filed testimony or any other document with the Clerk, please check with the Clerk to obtain the most recent version of the Service List.

Participants who wish to testify at the first hearing are directed to pre-file all of their testimony and any related exhibits no later than Thursday, October 4, 2012. See 35 Ill. Adm. Code 102.424(a). Participants who wish to testify at the second hearing are directed to pre-file all of their testimony and any related exhibits no later than Thursday, November 1, 2012.

The "mailbox rule" at 35 Ill. Adm. Code 101.300(b)(2) does not apply to the filing of this pre-filed testimony, and the Board's Clerk must receive these documents before the close of business on these deadlines. However, documents may be filed electronically though the Clerk's Office On-Line (COOL) from the Board's Web site at www.ipcb.state.il.us. 35 Ill. Adm. Code 101.302(d). Any questions about electronic filing through COOL should be directed to the Clerk's Office at (312) 814-3629.

Order of Hearing

The hearing officer intends to begin the first hearing with any pre-filed testimony and questions based upon it. See 35 Ill. Adm. Code 101.610(d). Participants who do not pre-file testimony for the first hearing will be allowed to testify and respond to questions as time permits after the conclusion of pre-filed testimony and questions based upon it. For the first hearing, all pre-filed testimony will be entered into the record as if read. See 35 Ill. Adm. Code 102.424(f). A brief summary of testimony will be allowed if a witness wishes to provide one before responding to questions.

The hearing officer intends to begin the second hearing with any participants who prefiled testimony for the first hearing and were not able to testify at that time. Participants who pre-filed testimony for the second hearing will then present that testimony and respond to questions. Participants who do not pre-file testimony for the second hearing will be allowed to testify and respond to questions as time permits after the conclusion of pre-filed testimony and questions based upon it. As at the first hearing, all testimony pre-filed for the second hearing will also be entered into the record as if read. See 35 Ill. Adm. Code 102.424(f). A brief summary of pre-filed testimony will be allowed if a witness wishes to provide one before responding to questions.

Participant wishing to offer a public comment at either hearing will be allowed to do so if time permits at the close of the testimony and questions. The Board's procedural rules also include an opportunity to file post-hearing comments. *See* 35 Ill. Adm. Code 102.108(b).

Service and Notice Lists

The hearing officer will establish and maintain both a Notice List and a Service List for this proceeding. See 35 Ill. Adm. Code 102.422(a), (b). The Notice List includes participants who receive copies only of the Board's opinions and orders and hearing officer orders. 35 Ill. Adm. Code 102.422(a). The Service List for this rulemaking is the list of persons who receive not only the Board's opinions and orders but also other filings such as pre-filed testimony. See 35 Ill. Adm. Code 102.422(b).

Please note that interested persons may now request electronic notice of filings by providing their e-mail address through COOL under this docket number R13-8. This electronic notice includes notice of the filing of documents that are not typically provided to persons on the Notice List. In addition, COOL provides links to documents filed with the Board, and those documents can be viewed, downloaded, and printed free of charge as soon as they are posted to the Board's Web site.
