



MOTION TO REQUEST EXTENSION OF TIME TO FILE RESPONSES TO REQUESTS TO ADMIT FACTS

NOW COMES the Complainant, PEOPLE OF THE STATE OF ILLINOIS, by LISA MADIGAN, Attorney General of the State of Illinois, to Section 101.618 (b) of the Illinois Pollution Control Board's Procedural Regulations and requests an extension of time to file Complainant's Responses to NACME Steel Processing, LLC's First Requests to Admit Facts to Respondent ("Responses to Requests"). In support thereof, the Complainant states as follows:

1. On September 5, 2012, People of the People of Illinois ("Complainant" or "People"), filed a one-count Complaint against NACME STEEL PROCESSING, LLC ("Respondent" or "Nacme") alleging violations of the Illinois Environmental Protection Act, 415 ILCS 5/1 *et seq.* ("Act") and the Illinois Pollution Control Board's ("Board") regulations thereunder ("Complaint").

2. On November 2, 2012, The People received service by Nacme of its Answer and Affirmative Defenses to the Complaint, which had been filed with the Board on November 1, 2012 ("Answer").

3. Pursuant to the Board's rules, the Illinois EPA was required to file a Response to Requests no later than November 30, 2012, twenty-eight (28) days after service, 35 Ill. Adm. Code 101.618(a).

4. Pursuant to the Board's rules parties may request more time to respond by filing a motion for an extension of time. 35 Ill. Adm. Code 101.618(b).

5. On November 26, 2012, Complainant finalized the Responses to the Requests for Illinois Environmental Protection Agency personnel signatures on Attestation verifying the Requests.


6. As of November 30, 2012, the Attorney General has not received the Attestation with IEPA signature.

WHEREFORE, the Complainant, PEOPLE OF THE STATE OF ILLINOIS, by LISA MADIGAN, Attorney General of the State of Illinois, requests an extension of time to service the Attestation for the Complainant's Responses to NACME Steel Processing, LLC's First Requests to Admit Facts to Respondent.
