PCB 13-10 (Third-Party Pollution Control Facility Siting Appeal)

HEARING REPORT

On December 4, 2012, a hearing in the above-captioned matter was held in the Winnebago County Administration Building, Room 303, 404 Elm Street, Rockford, Illinois. Hearing Officer Bradley P. Halloran presided.

Attorney Michael S. Blazer appeared and participated on behalf of the petitioner, Martin Maggio. Attorney David Kurlinkus appeared and participated on behalf of the respondent, Winnebago County Board (County Board). Attorneys George Mueller and Charles Helsten appeared and participated on behalf of respondent Winnebago Landfill Company, LLC. (WLC).

Preliminary Matters

On August 15, 2012, the petitioner filed a petition asking the Board to review a July 12, 2012 decision of the County Board granting an expansion of a pollution control facility. Petitioner appealed on the grounds that the County Board did not have proper jurisdiction to conduct public hearings on WLC's application due to its failure to serve notice and, that the proceedings were not fundamentally fair. On August 23, 2012, the Board accepted the petition for hearing. On December 4, 2012, at the hearing, petitioner orally withdrew its fundamental unfairness claim and, on January 2, 2013, filed a written motion for partial voluntary dismissal. Additionally, petitioner's deposition subpoena served on Derke Price was addressed. On November 8, 2012, Derke Price filed a motion to quash subpoena. At hearing, petitioner orally withdrew the deposition subpoena, making the motion to quash moot.

The petitioner offered exhibits into evidence at the hearing. An exhibit list itemizing the offered exhibits and summarizing their status is attached to this order.

Briefing Schedule

A post-hearing briefing schedule was discussed and it was agreed that petitioner's posthearing brief is due to be filed on or before January 2, 2013. Respondents' respective posthearing briefs are due to be filed on or before January 23, 2013. Petitioner's reply brief, if any, must be filed on or before January 30, 2013. The mailbox rule does not apply to petitioner's reply brief and all electronic or approved telefax filings must be received by the Clerk's Office no later than 4:30 p.m. of the due date. Public Comment must be filed on or before January 15, 2013.
