
AMENDED HEARING OFFICER ORDER

On December 19, 2012, the complainant filed motion for leave to file its response to respondents' motion to strike and dismiss filed November 30, 2012. To date, the respondents have not filed a response. Complainant's motion is granted to the extent that its response is now due to be filed on or before January 25, 2013. The respondents' reply, if any, is due to be filed on or before February 15, 2013.

Additionally, a telephonic status conference was held on January 14, 2013. The complainant stated that it has no objection to respondents' motion to consolidate, filed November 30, 2013, and will not be filing a response.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on March 21, 2013, at 9:30 a.m. The telephonic status conference previously scheduled for February 14, 2013, is hereby cancelled. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
