HEARING OFFICER ORDER


The parties are hereby notified that the above-captioned matter has been assigned to the hearing officer noted below. From this date forward, any document filed with the Clerk of the Board must also be served individually on the hearing officer.

On January 14, 2013, the complainant orally stated in a telephonic status conference that it will not be filing a response to respondents' motion to consolidate, filed November 30, 2012. The complainant further stated that it had no objection to the motion to consolidate.

Additionally, discussion on respondents' motion to strike and dismiss, filed November 30, 2012, was entertained. The complainant orally requested that it be given until January 25, 2013, to file its response to respondents' motion to strike and dismiss. The respondent had no objection. The complainant's request is granted and its response must be filed on or before January 25, 2013. The respondents must file their reply, if any, on or before February 15, 2013.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on March 21, 2013, at 9:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


