Project: Wood Stave Sewer Repair Project

Section C - Manufacturing Process

Process Description:

The Wood River Refinery treats all process sewer material in the refinery Waste Water Treatment Plant such that the Waste Water Treatment Plant effluent meets all NPDES Permit requirements and can be discharged to the Mississippi River. As part of the water treatment process, a treated water stream is routed from the main Waste Water Treatment Plant to polishing lagoons via an underground sewer, referred to as the Wood Stave Sewer. Any leak in the Wood Stave Sewer would allow refinery Waste Water Treatment Plant effluent to leak underground and eventually contaminate ground water. While the refinery Waste Water Treatment Plant effluent meets all NPDES Permit requirements, the slight quantity of sulfides, nitrates, ammonia, and Total Organic Carbon (TOC) present in the effluent would be considered pollutants if leaked to ground water.

Due to the age and previous damage to the Wood Stave Sewer, this Environmental project was implemented to prevent underground leaks in the Wood Stave Sewer. This project installed 200 feet of new underground piping to replace a damaged section of the Wood Stave Sewer and installed an Insituform lining in an additional 900 feet of the Wood Stave Sewer.

Materials Used in Process:

Waste Water Treatment Plant Effluent containing low levels of sulfides, nitrates, ammonia, and TOC

Section D - Pollution Control Facility Description

The Wood River Refinery completed the Wood Stave Sewer Repair Project primarily to prevent ground water pollution due to Waste Water Treatment Plant Effluent leaking into ground water. This project is considered a pollution control facility as it is necessary to provide a fully functional Waste Water Treatment Plant. The pollution control facility is 200 feet of new underground piping and an additional 900 feet of Insituform lining of the Wood Stave Sewer to prevent pollutants in the Waste Water Treatment Plant effluent from reaching ground water.

Due to the age and previous damage to the Wood Stave Sewer, this Environmental project was implemented to prevent underground leaks in the Wood Stave Sewer. Any leak in the Wood Stave Sewer would allow refinery Waste Water Treatment Plant effluent to leak underground and eventually contaminate ground water. While the refinery Waste Water Treatment Plant effluent Plant effluent meets all NPDES Permit requirements, the slight quantity of sulfides, nitrates, ammonia, and Total Organic Carbon (TOC) present in the effluent would be considered pollutants if leaked to ground water.

The Wood River Refinery receives no financial benefit from this project.
