Dear Mr. Therriault:

As the Mayor of the City of Waukegan, I would like to be on record with the Illinois Pollution Control Board as supporting Midwest Generation in its request for short-term relief from state regulations governing emissions at its coal-fired power plants.

The Waukegan Station is a vital part of the economic engine of Waukegan and Lake County and I would hope that we will do whatever possible to ensure the long-term viability of the plant. Midwest Generation is a company that conducts itself with a great deal of integrity and responsibility to stakeholders – whether employees, policymakers or communities surrounding its plants. Its request for a variance is straightforward and reasonable.

All it seeks is permission to invest less than it otherwise would have during just two years of the State's 12 year emissions reductions program. The company is not looking to duck its responsibilities; it merely wants to defer some capital expenses for environmental improvements as it goes through a financial restructuring.

Ever if granted the variance, Midwest Generation would still hit the state-mandated emissions targets by the end of the program in 2019. And, its emissions from 2013-16 would be less than projected when current state regulations were adopted in 2007. In other words, the request would result in lower emissions than currently required.

Midwest Generation contributes a great deal to the Illinois economy. It provides 850 good jobs for its employees and hundreds more for building and construction workers hired for special projects in the plants. It purchases hundreds of millions of dollars of goods services from Illinois companies. It pays nearly \$5 million in property taxes to support local schools and municipal

services. It has always shown a strong commitment to corporate citizenship through involvement in community, civic and charitable organizations.

Finally, there is an issue of fundamental fairness. Just last September, the Pollution Control Board granted Ameren a variance that was similar in many respects to what Midwest Generation seeks. In fact, the major difference is that Midwest Generation's request is more limited in scope than Ameren's.

I respectfully request that the Board approved Midwest Generation's request.

This letter is about the people, all the people. Our first concern is the 550 plus Local 15 members that work at these stations; include their spouses and families and that number can quickly triple in size. Add on the 300 management people that also work at these plants, and their spouses and families and suddenly we are concerned about a couple of thousand people. Now add in the hundreds of tradesmen and women that work in these stations; and don't forget their families. But that's not all. We care about the rest of the people in Illinois and the surrounding states. Not just the environment but the economy also.

MWGen is asking for a little bit of time. The economy has hit this industry extremely hard and forcing them to hold to a timeframe agreed to years ago may be enough to cause all or many of these stations to close. That doesn't help anyone except possibly their competitors. And we all know that when competition is down, prices go up, costing everyone more money. MWG is not asking for an advantage but for a level playing field.

MWG is asking for two things. First, a small variance to the emission rate limit for sulfur dioxide for a two year period (2015 and 2016) so that they can delay spending over \$200 million in capital expenses in 2013 and 2014. This makes a lot of sense since they filed for Chapter 11 bankruptcy protection in December of 2012. Even if granted this variance, the Company guarantees the **actual tons of emissions** will decline in 2015 and 2016, returning to the original CPS emission rate limit in 2017, 2018 and 2019.

Second, MWG is asking for a five-month extension of the CPS' requirement to install additional pollution control equipment on one unit at Waukegan Station. The company has agreed not to operate the unit after Dec. 31, 2014 until the work is completed, and will retire the unit if the equipment is not installed by May 31, 2015.

Even if granted this variance, MWG will spend around \$230 million on pollution controls in 2013 and 2014. From 2013-2016 actual sulfur dioxide emissions will be over 3000 tons less than originally projected. We have seen this company spend hundreds of millions of dollars on pollution control equipment. MWG has met some regulations, mercury for example, over five years ahead of time. The company has achieved the sulfur dioxide 2013 emission rate limit in 2011 and year-to-date in 2012 and is not seeking changes to the CPS for 2013 and 2014.

We are concerned about the environment and would not support this variance if we believed it would have a negative impact. Our members live in these areas and work in these stations. Most of them have children and grandchildren that live in these areas also.

We are asking you to support this variance and give MWG a little bit of time to get through an extremely tough financial period, not by giving them a break, but by realizing the electrical generating industry has seen some major changes since MWG's agreement with the Illinois Environmental Protection Agency in 2007. In the long run this will help the environment and the economy.

Dear Mr. Therriault:

I respectfully request that the Illinois Pollution Control Board approve Midwest Generation's request for temporary relief from comprehensive state regulations that have ensured ongoing reductions in air emissions from the company's plants from 2008 to 2019.

Midwest Generation is merely asking permission to reduce, not eliminate, spending on environmental improvements during two years in the middle of a 12-year emissions reduction program. The company has been meeting all of its environmental commitments under state regulations, and even with the variance, would meet all requirements by the time the state program ends in 2019.

I also would ask that the IPCB consider that it granted Ameren relief just a few months ago that went beyond what Midwest Generation is requesting.

Midwest Generation employs 845 men and women, 64 percent of them union members. It provides jobs for hundreds of additional workers, most of them members of the building and construction trades. It spends close to \$400 million on goods and services from Illinois companies and to support various Illinois organizations, and nearly \$5 million on local property taxes. And it provides energy to homes and businesses throughout our state. It is deserving of your support for the requested variance.
