**HEARING OFFICER ORDER**

By agreement, respondent must file its answer or other pleading, including a motion to stay these proceedings and/or motion to dismiss or strike on or before May 20, 2013.

The parties or their legal representatives are directed to participate in a telephonic pre-hearing conference with the hearing officer on May 2, 2013, at 9:00 a.m. The telephonic conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




