The company has been meeting all of its environmental commitments under state regulations, and even with the variance, would meet all requirements by the time the state program ends in 2019.

I also would ask that the IPCB consider that it granted Ameren relief just a few months ago that went beyond what Midwest Generation is requesting.

Midwest Generation employs 845 men and women, 64 percent of them union members. It provides jobs for hundreds of additional workers, most of them members of the building and construction trades. It spends close to \$400 million on goods and services from Illinois companies and to support various Illinois organizations, and nearly \$5 million on local property taxes. And it provides energy to homes and businesses throughout our state. It is deserving of your support for the requested variance.
