**STATUS REPORT AND REQUEST FOR SCHEDULING CONFERENCE AND/OR  
SCHEDULING ORDER**

On behalf of the Respondents, **FELIPE GOMEZ, ESQ.**, hereby files this **Status Report and Request for Scheduling Conference and/or Scheduling Order**:

1. Counsel for EOR reports that on February 19, 2013, EOR filed a Motion to Reconsider the January 10, 2013, IPCB Order finding that IEPA and IPCB, and not IDNR, have jurisdiction over EOR in this matter, and that on February 26, 2013, the State filed a Motion to Strike that filing, with a Response from EOR being due on or about March 18, 2013.
2. Counsel for AET reports that there is an issue as to the due date for AET's Motion to Reconsider the Board's January 24, 2013, Order, given that the January 24, 2013, Order was not received by AET counsel until February 15, 2013, as shown by the green card scanned into the docket (Courtesy Copy attached as Att. 1), thus under 35 IAC 101.300(c) and (d) the 35 day period for appeal or reconsideration putatively began February 15, 2013.
3. Investigation by AET counsel of the delay between mailing and receipt of notice/envelope reveals:
  - \* The certified letter envelope with the Order has a postmark of Friday, January 25, 2013 (Att. 2 hereto);
  - \* USPS tracking website indicates the letter was delivered to AET counsel's Post Office on Monday January 28, 2013 (Att. 3 hereto);
  - \* The Order's envelope bears a notation appearing to indicate that, for as of yet unknown reasons, a notice was not left for counsel notifying of the envelope until February 9, 2013 (Att. 2).
4. Given the foregoing, and to eliminate confusion and streamline the final motion practice in this matter, AET and EOR have earlier today provided advance e-notice and a voice mail of the intent to file this Statue Report/Request, including the proposed schedule, and copies of the attached documents, and have requested the State's concurrence to a scheduling order as requested below.
5. AET and EOR proposes a scheduling conference for March 5, 2013, or, alternatively, that the HO enter following schedule and due dates in a scheduling order:
  - A. Friday, March 8, 2013: AET Motion to Reconsider January 24, 2013, Order;
  - B. Monday, March 18, 2013: EOR Response to State's February 26, 2013, Motion to Strike February 19, 2013, Motion to Reconsider;
  - C. Friday, April 19, 2013: State Response to AET Motion to Reconsider.
6. In the event for some unexpected reason the due date for AET's Motion to Reconsider is found to be or is March 5, 2013, AET requests this Status Report/Request be considered a request for an extension of time to file its Motion until March 8, 2013.

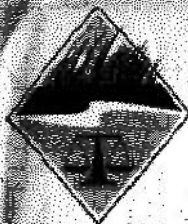

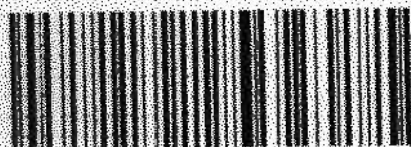

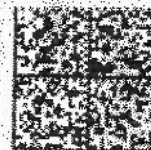
