Respondents must file their reply to complainant's response to respondents' motion to strike and dismiss the complaint, filed February 27, 2013, on or before March 29, 2013.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on May 23, 2013, at 9:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
