HEARING OFFICER ORDER

On March 27, 2013, respondents Ironhustler Excavating, Inc. and Ron Bright requested an extension of time to file a response to the People's motion for summary judgment. This is the third request for a deadline extension. The People agreed to the first two extensions, but now object.

To further the Board's interest in expediting the resolution of enforcement actions, this hearing officer will grant only one motion for extension of time unless the People agree to additional extensions. Therefore, the third request for extension of time is denied, and respondents should file the response, along with a motion for leave to file *instanter*, as soon as possible. When the response is filed, the deadline for the People's reply will be reset.

The parties are reminded to participate in a telephone status conference with the hearing officer at 10:00 a.m. on July 8, 2013. The status conference shall be initiated by the People.
