I started working for my Father Thomas Johnson at Johnson Tire Service in Grayville Ill when i was sixteen I've changed tires for 28 years' My Father and Grandfather ran this bussiness for 78 years, thought i had it made. One day in 2009 Father told me we were shutting our doors after 78 years I had 4 days to figure something out not knowing how to even run a bussiness with not a dollar in my pocket, Iwas desperate to help my my Father so iwent to Scheonheit Trucking one of our best customers freinds of the family. Iwanted give back what I felt like owed my family, it was my time to make stand for what I beleived in, what used to be the American way in a business. I started MJ tire at Schoenheits, I built my business for Three years having the tire changing knowledge, I kept most of the tire business my Father and Grandfather had for years. I did not know what it took to run a bussiness, until i realized how much the State of ILL works on a person trying to run a small bussiness, its very hard. but dont get me wrong, I understandpollution in the air is not a good thing. So I am very Sorry for that. I don t expect for u to feel sorry for me, but i wanted you to know that all i have done is make enough to pay my bills but when you see tires layn around in piles every where els besides mine, ihave difficulty understanding. I'm atrue American and worked hard all of my life for every dollar. Now I know why my Father shut down, laws are shutting small town bussiness down, like mine, As of March 10th of 2013 I shut my doors< and a bussiness bought me out, so I' recently relocated tires etc. to this business , better location south of town working by the hour I plan on keeping good faith keeping tires disposed of at this location and tires will be in a enclosed building, I hope the EPA and the State of ILL will let me make a 50dollars aweek out of my paycheck for the 1500.00 fine that I dont have. So if u will work with me i CAN GET THIS solved. To whom it may concern I also pay 170.00 a week in child support for two daughters , plus Im married with a wife and raising two daughters of my own.I will send 100.00 dollars to IEPA.
