MOTION TO EXTEND DISCOVERY SCHEDULE

NOW COMES Complainant, PEOPLE OF THE STATE OF ILLINOIS, by LISA MADIGAN, Attorney General of the State of Illinois, and respectfully requests that the Illinois Pollution Control Board ("Board") extend the discovery schedule in this matter for fourteen days, or to May 1, 2013.

1. On March 7, 2013, the Board set a date of April 17, 2013 for completion of depositions in this case. The April 17, 2013 date had been requested by Complainant. As of April 17th, no firm hearing date had yet been established.

2. Hearing has now been set for May 21, 2013. Counsel for the parties have been in consultation, and would like to take the final depositions in this case on April 30 and May 1, 2013. The need for additional time arose due to issues with availability of the witnesses and counsel.

3. An extension until May 1, 2013 will not violate the Board's rules, which require that discovery be completed within 10 days of the date of Hearing. If an extension is granted, discovery will close 20 days prior to the May 21, 2013 hearing date.

4. Counsel for Respondent has reviewed this Motion and agrees with the relief requested herein, will not file any response, and has authorized the undersigned to so state.

WHEREFORE, Complainant, People of the State of Illinois, respectfully requests that the Board extend the deadline for close of depositions in this case to May 1, 2013.




