MOTION TO WITHDRAW FIRST AMENDED COMPLAINT

Complainant, the People of the State of Illinois, by and through its attorney, Lisa Madigan, Attorney General of the State of Illinois, hereby moves the Pollution Control Board ("Board"), for leave to withdraw its First Amended Complaint in this action, in anticipation of its forthcoming motion for leave to file a Second Amended Complaint. In support of this motion, Complainant states as follows:

1. On September 8, 2009, Complainant initiated this action with the filing of its Complaint, which named only one Respondent, Montalbano Builders, Inc. ("Montalbano").

2. On August 3, 2011, Complainant filed its First Amended Complaint with the Board, naming two additional Respondents to this action, specifically, First American Properties, LLC ("First American") and MBC XIV, LLC ("MBC"). Complainant's prior counsel did not seek the Board's leave prior to filing its First Amended Complaint.

3. On February 7, 2013, upon the retirement of the Complainant's prior counsel, the undersigned counsel entered his appearance in this case. In the course of reviewing the docket in this case, the undersigned counsel determined that neither First American nor MBC had ever

been served with the First Amended Complaint.

4. On March 1, 2013, Complainant filed its Motion to Voluntarily Dismiss First American Properties, LLC. On March 31, 2013, the Board granted Complainant's motion and dismissed First American from this action.

5. Complainant anticipates filing a Second Amended Complaint with the Board before the end of May 2013, after first seeking Board's leave to file this pleading, which will name Montalbano, MBC, and three additional Respondents to this action.

WHEREFORE, Complainant, the People of the State of Illinois, respectfully prays that its motion be granted.
