
HEARING OFFICER ORDER

On July 15, 2013, all parties participated in a telephonic status conference with the hearing officer. The petitioner stated that it had recently received the Corrective Action Plan approval letter from the respondent. The petitioner stated that it appears acceptable and will circulate for signatures. To that end, the petitioner stated that it anticipates filing a motion to voluntarily dismiss the above-captioned appeal prior to the next status conference.

The petitioner stated that it will file a waiver of the statutory decision deadline to and including November 7, 2013.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on July 30, 2013, at 10:00 a.m. The telephonic conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a motion to voluntarily dismiss is filed prior to the next status conference, the conference will be cancelled without further order.

IT IS SO ORDERED.




