HEARING OFFICER ORDER

On July 18, 2013, all parties participated in a telephonic status conference with the hearing officer. The complainant stated that drafts of the stipulation and proposal for settlement (stipulation) as to both respondents are being internally reviewed. The complainant anticipates that respective stipulations will be filed prior to the next status conference.

To that end, it was agreed upon by complainant and Midwest Environmental that its answer or other response is now due to be filed on or before October 1, 2013.

On June 13, 2013, respondent Universal Asbestos Removal, Inc. (Universal Asbestos) filed a motion for leave to file its answer, instanter. Complainant has not filed a response, and at the telephonic conference, stated that it had no objection. Universal Asbestos' motion is granted.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on September 19, 2013, at 9:30 a.m. The telephonic conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, the respective stipulations are filed prior to the next status conference, the conference will be cancelled without further notice.
