## PUBLIC COMMENTS OF THE ILLINOIS EPA

NOW COMES the Illinois Environmental Protection Agency (Illinois EPA), by and through its attorney, and hereby submits its Public Comments as directed by the Hearing Officer Order entered on July 16, 2013, in the above-captioned rulemaking.

## Procedural Background

On March 18, 2013, the Illinois EPA filed its regulatory proposal to amend the vapor recovery rules with the Illinois Pollution Control Board (Board). On April 4, 2013, the Board accepted the Illinois EPA's proposal for hearing and adopted the proposed amendments for first notice. The first hearing in this matter was held on May 8, 2013, in Springfield, Illinois. The second hearing in this matter was held on June 5, 2013, in Chicago, Illinois. At the close of the hearings in this matter, the Hearing Officer set a public comment deadline of July 8, 2013.

On July 8, 2013, the Illinois Petroleum Marketers Association (IPMA) filed a public comment requesting the Board and Illinois EPA to reconsider the January 1, 2014 effective date and allow the rule amendments to become effective immediately. PC2 at p. 1. On July 16, 2013, the Hearing Officer entered an Order directing the Illinois EPA to file a public comment in response to IPMA's public comment. The Hearing Officer directed the Illinois EPA to file its public comment by July 31, 2013.

## Illinois EPA Response to IPMA Public Comment

The Illinois EPA reached out to IPMA to discuss the concerns that formed the basis for

its public comment and to resolve those concerns in a spirit of cooperation. The Illinois EPA

acknowledges that, for industry, this is a time of regulatory compliance uncertainty. Further, the

Illinois EPA understands the economic conundrum for industry during this time. After informed

discussion between the Illinois EPA and IPMA, the Illinois EPA understands that IPMA's

concerns have been addressed. The Illinois EPA has committed to IPMA that it will continue

working with IPMA should any compliance issues arise in a way that will be understanding of

this situation and will seek to expeditiously and amicably resolve any such issues. As a result,

the Illinois EPA understands that an immediate effective date is no longer a request of or desired

by IPMA and that IPMA is in agreement with this statement. See Exhibit 1.

WHEREFORE, the Illinois EPA respectfully submits these comments, requests the Board

to maintain the January 1, 2014 effective date, and requests the Board to proceed expeditiously

to second notice.
