**HEARING OFFICER ORDER**

On August 27, 2013, all parties participated in a telephonic status conference with the hearing officer. The complainant stated that it forwarded a draft stipulation and proposal for settlement for its review. The respondent, however, stated that it was recently contacted by the United States Environmental Protection Agency (USEPA) regarding additional issues with the site. To that end, the respondent stated that it intends to file a motion for stay in this matter until USEPA's involvement in this matter is resolved.

The parties intend to have additional discussions prior to the next status conference.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on October 10, 2013, at 9:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.


